Dr. Tremain has worked as a hospital-based clinician and teacher, and served as Chief Medical Officer for over 20 years. He was the executive sponsor for improvement teams that were awarded national mentor status by the Institute for Healthcare Improvement in the areas of medication reconciliation, rapid response teams, and ventilator-associated pneumonia.

Currently, Dr. Tremain serves as the National Clinical Lead for the American Hospital Association/HRET Hospital Improvement Innovation Network (HIIN) efforts to enhance antibiotic stewardship and reduce harm from adverse drug events. He is the primary author of HRET HIIN Antibiotic Stewardship, Adverse Drug Events, and VTE Change Packages. Dr. Tremain serves as an advisor to state hospital associations, boards, hospital leaders, and medical staffs regarding the business case for quality, physician leadership development, and high reliability principles. He also has trained over 300 Canadian physician leaders in Safety Culture and Process Reliability as guest faculty of the University of British Columbia. He has been a member of the faculty of the Institute for Healthcare Improvement.

Dr. Tremain is a certified physician TeamSTEPS trainer. He was Board certified in Family Medicine for 35 years and is a Certified Physician Executive. He earned his MD degree from the UCLA School of Medicine.
